## SECTION 4 : FIRST AID MEASURES

As a general rule, in case of doubt or if symptoms persist, always call a doctor.

### 4.1. Description of first aid measures

#### In the event of exposure by inhalation :

In the event of massive inhalation, remove the person exposed to fresh air. Keep warm and at rest.

#### In the event of splashes or contact with eyes :

Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists : Get medical advice/attention.

#### In the event of splashes or contact with skin :

Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Get medical attention if symptoms occur.

#### In the event of swallowing :

Seek medical attention, showing the label.

## SECTION 5 : FIREFIGHTING MEASURES

Flammable.

Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

### Suitable methods of extinction

Prevent the effluent of fire-fighting measures from entering drains or waterways.

### 5.2. Special hazards arising from the substance or mixture

A fire will often produce a thick black smoke. Exposure to decomposition products may be hazardous to health.

Do not breathe in smoke.

In the event of a fire, the following may be formed:

- carbon monoxide (CO)
- carbon dioxide (CO<sub>2</sub>)

In a fire or if heated, a pressure increase will occur and the container may burst. Bursting aerosol containers may be propelled from a fire at high speed. Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.

Move containers from fire area if this can be done without risk. Use water spray to keep fire-exposed containers cool.

### 5.3. Advice for firefighters

Fire-fighting personnel are to be equipped with autonomous insulating breathing apparatus.

If possible, stop the product stream. Spray from a protected position till the containers are cool. If possible, take the aerosols outside. Keep public on a distance.

## SECTION 6 : ACCIDENTAL RELEASE MEASURES

### 6.1. Personal precautions, protective equipment and emergency procedures

#### For first aid worker

First aid workers will be equipped with suitable personal protective equipment (See section 8).

Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal.

Prevent any material from entering drains or waterways.

Do not spray on a naked flame or any incandescent material.

Do not pierce or burn, even after use.

Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.

Keep packages tightly closed and away from sources of heat, sparks and naked flames.

Do not use tools which may produce sparks. Do not smoke.

Prevent access by unauthorised personnel.

#### Recommended equipment and procedures :

Observe precautions stated on label and also industrial safety regulations.

Do not breathe in aerosols.

#### Prohibited equipment and procedures :

No smoking, eating or drinking in areas where the mixture is used.

### 8.2. Exposure controls

#### Personal protection measures, such as personal protective equipment

- Use personal protective equipment that is clean and has been properly maintained.
